

Utah Soccer Association – Membership Waiver

By signing this registration application, I agree to abide by the laws and rules of the game of soccer as promulgated by the Federation Internationale de Football Association (FIFA), the United States Soccer Federation (USSF), the United States Adult Soccer Association (USASA), the Utah Soccer Association and any properly affiliated and associated leagues, clubs and teams which may sanction a competition in which I choose to participate. I further agree that failure to abide by these laws and rules may result in the revocation of the right to play granted by the acceptance of this registration.

Soccer is a contact sport involving risk of serious injury, disability, or death. Not all risks are foreseeable. In consideration of being allowed to participate, I agree to release, waive, and covenant not to sue the United States Soccer Federation, United States Adult Soccer Association, Utah Soccer Association or their affiliates on account of injury, death or property damage alleged to be caused in whole or part by affiliates' actions or omissions and have also accepted the terms of the separate liability waiver that is included in this set of waivers. No Refund Policy Statement

This registration application is valid for the period starting from your registration date until the end of 2017. It is understood that once you have paid the registration fee, this registration is non-transferable and refunds or partial refunds are not given. Your registration fee pays for your membership with the Utah Soccer Association as well the as United States Adult Soccer Association and the United States Soccer Federation which entitles you to play for a designated team until the end of the 2017 season, whether you play in all, one or no games.

THE TEAM FOR WHICH YOU ARE REGISTERED IS AFFILIATED WITH THE UTAH SOCCER ASSOCIATION. YOU MUST BE REGISTERED VIA OUR ON-LINE REGISTRATION SYSTEM AND IN ORDER TO STAY ELIGIBLE FOR PLAY, YOU ARE REQUIRED TO PAY YOUR TOTAL REGISTRATION FEES IN A TIMELY MANNER, AS AGREED AT THE TIME OF THE REGISTRATION PROCESS. YOUR TEAM MUST ACCEPT YOUR REGISTRATION PRIOR TO YOU BECOMING ELIGIBLE TO PLAY. YOU WILL BE ELIGIBLE TO PLAY WHEN YOUR INFORMATION IS TRANSFERRED TO EACH GAME ROSTER AND YOU HAVE NOT BEEN CROSSED OFF. PLAYING ILLEGALLY WILL RESULT IN SANCTIONS AGAINST THE TEAM AND/OR PLAYER.
